

Attic Self Storage Cardboard Box Competition Terms & Conditions

The promoter is: Attic Self Storage Limited (company no. 5999141) whose registered office is at 500 Wick Lane, London E3 2TB.

The competition is open to residents of the United Kingdom aged 18 years or over. Employees of Attic Self Storage and their close relatives and anyone otherwise connected with the organisation, judging or drawing of the competition are not permitted to enter.

There is no entry fee.

By entering this competition, an entrant is indicating his/her agreement to be bound by these terms and conditions.

Entry is by way of posting a photo to the posed question in the relevant Attic Self Storage post on Facebook. The question is "Show us a photo or a sketch of a creative, inspirational or innovative idea for using cardboard boxes"

Entries involving indecent or discriminatory language will be hidden and withdrawn from the draw.

Closing date for entry will be 23:59 on Tuesday the 5th of January 2021. After this date entries to the competition will continue to be accepted, but will no longer be eligible to win the prize.

No responsibility can be accepted for entries not received for whatever reason.

The rules of the competition and how to enter are as follows:

1. Entrants must comment with a photo/image on the Attic Self Storage facebook post with their idea for using cardboard boxes.
2. The promoter reserves the right to cancel or amend the competition and these terms and conditions without notice in the event of a catastrophe, war, civil or military disturbance, act of God or any actual or anticipated breach of any applicable law or regulation or any other event outside of the promoter's control. Any changes to the competition will be notified to entrants as soon as possible by the promoter.
3. The promoter is not responsible for inaccurate prize details supplied to any entrant by any third party connected with this competition.
4. The winners will be selected based on the most creative, funny or inspirational use of cardboard boxes that they suggest as judged by a panel of judges from Attic Self Storage and an independent external judge,
