

Attic Self Storage Hand Me Downs Terms & Conditions

The operator is: Attic Self Storage Limited (company no. 5999141) whose registered office is at 3rd Floor, 72 Borough High Street, London, SE1 1XF.

Campaign Overview:

1. During the month of September 2021, Attic Self Storage will be teaming up with the Toy Project with the aim of collecting pre-loved toys and passing these onto to the Toy Project for repurposing and selling / passing on to beneficiaries as they see fit.
2. People wishing to donate toys can do so at one of the 4 Attic branches by handing in a maximum of 4 bags or boxes of toys per household to a member of the Attic Team or by requesting a collection from their home by the Attic team.
3. The campaign will run from 01/09/21 to 30/09/21. After this date Attic will be unable to accept any donations or make any collections.

General Donations

6. There is no cost to making a drop off or having a donation collected.
7. Please do not include the following items as they cannot be accepted: Soft / cuddly toys, Board games, Toy Guns
8. Donated items should be in a clean state.
9. Attic reserves the right not to accept donations if they are not in a clean state, are above the number per household or are deemed to be inappropriate.
10. All acceptable donations will be passed on to The Toy Project
11. Attic will not be able to return any donations once they have been received.

Making Donations to Stores

1. Attic Stores will accept donations of up to 4 boxes / bags of toys per household.
2. Donations can be made at the following locations from the 01/09/21 to 31/09/21.

3. Donations must be made during office hours which are as below:
 - Mon-Fri: 08:30 – 18:30
 - Sat: 09:30 – 18:30
 - Sun: 10:00 – 16:00
4. All donations must be handed to a member of store staff and must not be left outside, by entrances, or anywhere around our store. Any donations left outside our premises will be considered as and treated as fly tipping.

Collections & Collection Requests:

5. Collections can be requested by entering details onto the form on the Attic website.
6. Availability for collections is limited and will be on a first come first served basis. Attic reserves the right to decide on the allocation of collections on the basis of location and feasibility.
7. Attic reserve the right to withdraw collections or change collection days and time if necessary due to our van and driver being needed for other urgent, non-planned, business issues that may arise.
8. We will notify requestors of collections if we are able to make a collection and on what day and approximate time this will be. Regrettably we are not able to offer specific time slots or attempt a re-collection if items are not available on the first attempt.
9. Filling in the form does not guarantee a collection.
10. Collections will only be able to be made within 1.5 miles of each of our store locations and will be in each area on the following days:
 - Attic Self Storage Bow, E3 2TB, Wednesday the 8th of September 2021
 - Attic Self Storage Kings Cross, N7 9PQ, Wednesday the 15th of September 2021
 - Attic Self Storage Marylebone, NW1 6XX, Wednesday the 22nd of September 2021
 - Attic Self Storage Harrow, HA7 1EE, Wednesday the 29th of September 2021.
11. Attic reserves the right not to accept the donations during a collection if they do not meet the general donation criteria.
12. The Attic donation collection service can be used solely for the purpose of making a donation of toys to this campaign. This service cannot be used for other purposes including transporting people anywhere or disposal of rubbish.

General Conditions:
