

## **Attic Self Storage Christmas Prize Draw Terms & Conditions**

The promoter is: Attic Self Storage Limited (company no. 5999141) whose registered office is at 500 Wick Lane, London E3 2TB.

The prize draw is open to residents of the United Kingdom aged 18 years or over. Employees of Attic Self Storage and their close relatives and anyone otherwise connected with the organisation, judging or drawing of the competition are not permitted to enter.

There is no entry fee.

By entering this prize draw, an entrant is indicating his/her agreement to be bound by these terms and conditions.
